**WHEREAS, DAIRY PRODUCTION**, a component of Agriculture Sector has been evaluated to hold immense potential in realizing the agri-industrial goals of the provincial Government;

Albano** dispensed the **Provincial Program Management & Implementing Unit (PPMIU)** of Isabela to prepare the **Provincial Commodity Investment Plan** for the **Dairy Development of the Province of Isabela** under the auspices of **Dr. Angelo C. Naui, Provincial Veterinarian**, and **Mr. Danilo B. Tumamao, MPA, Provincial Agriculturist** with the corroboration of the **Department of Agriculture, RO2** and the **Philippine Carabao Center (PCC)** which undertook a study, thru a **Value Chain Analysis (VCA)** of the present status and prospects of the Dairy industry in Region 02 and particularly in the province of Isabela;

**WHEREAS**, Provincial Commodity Investment Plan (PCIP) is an essential requirement and step in the qualification and participation of PLGU-Isabela in the Rural Development Programs of the Department of Agriculture. The Project under the PRDP is inclusive of Farm-to-Market Roads, Bridges, Stock infusion, Provision of Animal Facilities and Equipment, Establishment/Improvement of Milking Barns and Milk Processing Center, Establishment of Research and Training Center and Central Milk Processing Plant, Skills Training and Market Research and Development;

**WHEREFORE**, Considering its urgency and importance, upon motion of **HONORABLE KIRYLL S. BELLO**, Chairman, Committee on Agriculture, duly seconded and unanimously approved by all Members in a session duly assembled, it was-
